Note from the Assessor:

BONNY MOORE

In 1994, Proposal "A" was approved by taxpayers to establish "Taxable Value" as the basis for the calculation of property taxes. Before Proposal "A," property taxes were based on Assessed Value. Increases in Taxable Value are limited to the percent change in the rate of inflation or 5%, whichever is less, unless you add or build something new or if there is a transfer of ownership.

Since 1994 the highest annual increase in Taxable Value has been 4.4%, and most years, much less. This past year the inflation rate has been over 8%. Because of the limitations established by Proposal "A," the 2023 Taxable Value inflation rate multiplier will increase to the maximum of 5%. If you have built something new or there was a sale or transfer of the property, the taxable value increase will be higher.
